APPLY FOR YOUR VISA NOW

It is advised to apply for your visa early in the year to increase your chances of being issued one. If you're interested in attending the Expo with an official delegation, reach out to your local U.S. Commercial Service office.

The following are some useful visa applications tips:

- Apply as soon as possible.
- Attaching evidence of your previous visits to the Annual Meeting & Clinical Lab Expo may help shorten the application processing time.
- Attaching evidence of your intended return trip to your home country can shorten the application processing time.
- If your local U.S. Consular Office requests that you obtain a "Letter of Invitation" from ADLM, please visit our website at myadlm.org/letterofinvitation.

International visitors attending the event are advised to register in advance prior to traveling to the meeting to avoid long wait times. We recommend you register by June 8, 2024, through fax, mail, or the [ADLM website](https://myadlm.org).
